The Company hereby announces that the Company will conduct PMTHMETD in the following ways:

- (i) carrying out the conversion of Mandatory Convertible Bonds ("OWK") in the amount of RP1,000,000,000,000 (one trillion Rupiah) based on the Deed of Issuance of Mandatory Convertible Bond Agreement No. 28 dated December 28, 2020, which was made before Ashoya Ratam, S.H., M.Kn., Notary in South Jakarta between the Company as the issuer and PT Sarana Multi Infrastruktur (Persero) as the bondholder ("Issuance Agreement") as approved by the Extraordinary General Meeting of Shareholders of the Company on November 20, 2020, by issuing new shares without pre-emptive rights in the amount of 5,102,040,816 (five billion one hundred and two million forty thousand eight hundred and sixteen) Series C shares with a nominal value of Rp196 (one hundred and ninety-six Rupiah) per share ("OWK Conversion"); and
- (ii) carry out the conversion of creditors' debts (with the list as attached) as an implementation of the Composition Agreement dated June 17, 2022 which has been homologated and ratified by the Commercial Court at the Central Jakarta District Court through Decision No. 425/Pdt.Sus-PKPU/2021/PN. Niaga.Jkt.Pst dated June 27, 2022, which becomes final and binding through Supreme Court Decision No. 1454 K/Pdt.Sus-Bankrupt/2022 which was concluded on September 26, 2022 ("Composition Agreement"), as approved by the Company's Extraordinary General Meeting of Shareholders on October 14, 2022, by issuing new shares without pre-emptive rights in the amount of 21,329,763,265 (twenty-one billion three hundred twenty-nine million seven hundred and sixty-three thousand two hundred and sixty-five) Series C shares with a nominal value of Rp196 (one hundred and ninety-six Rupiah) per share ("Creditor Debt Conversion").

The implementation of PMTHMETD in the form of OWK Conversion and Creditor Debt Conversion is carried out in order to improve financial position as referred to in Article 3 letter (a) of POJK 14/2019. The schedule for the implementation of PMTHMETD is as follows:

In connection with PMTHMETD transactions:

(i) Based on Article 5 of Government Regulation No. 44 of 2005 on Procedures for State Capital Participation and Administration in SOEs and Limited Liability Companies (as amended, PP 44/2005), OWK Conversion is an addition to State Capital Participation (PMN) in SOEs in which there are state-owned shares. Therefore, in accordance with the provisions of Article 4 paragraph (4) of Law No. 19 of 2003 on State-Owned Enterprises (as amended by Law No. 11 of 2020 concerning Job Creation), the addition of PMN through OWK Conversion must be determined by a Government Regulation.

On December 12, 2022, the Government issued Government Regulation No. 51 of 2022 concerning the Addition of State Capital Participation of the Republic of Indonesia into the Share Capital of Perusahaan Perseroan (Persero) PT Perusahaan Penerbangan Garuda Indonesia Tbk.

(ii) based on Article 9 paragraph (1) of PP 44/2005, the issuance of new shares in connection with the Conversion of Creditor Debt in the context of restructuring which results in the dilution of the Government's share ownership in the Company is a reduction in the percentage of PMN in SOEs in which there are already State-owned shares. Therefore, in accordance with the provisions of Article 4 paragraph (4) of Law No. 19 of 2003 on State-Owned Enterprises (as amended by Law No. 11 of 2020 concerning Job Creation), the reduction of PMN through the conversion of OWK must be determined by a Government Regulation.

In accordance with Article 22 paragraph (3) of PP 44/2005, the Government will issue a Government Regulation related to changes in the state share ownership structure as a form of orderly administration of PMN, after the capital increase transaction with Pre-emptive Rights ("PUT II") and PMTHMETD is completed.

PMTHMETD will be carried out at an exercise price of Rp196 (one hundred and ninety-six Rupiah) per share which was determined by taking into account the fair price assessment of the Company's shares by an independent appraiser, in accordance with the Composition Agreement. The exercise price of PMTHMETD has been determined in accordance with the provisions of the applicable laws and regulations in the capital market,

namely Regulation Number 1-A concerning the Listing of Shares and Equity Securities Other Than Shares Issued by Listed Companies, Appendix II to the Decree of the Board of Directors of the Indonesia Stock Exchange No. Kep-00101 / BEI / 12-2021 dated December 21, 2021.
